

WINTERHAVEN KENNELS POMERANIAN PURCHASE CONTRACT

This Pomeranian puppy or adult has been examined by our Veterinarian at Drayton Veterinary Clinic. You will receive records of vaccinations, flea treatments, worming, microchip ID and Vet examination this Pomeranian has had up to date of purchase.

The Pomeranian will be registered with The Canadian Kennel Club. Sold as a Pet Pomeranian this is a NON BREEDING CONTRACT and the Registration Paper will be stated as such by The Canadian Kennel Club and mailed to the buyer. Neutering/spaying of this Pomeranian is the buyers cost and responsibility and be done by 6 months of age.

The buyer understands that there is no guarantee on coat, size, colour, weight, behaviour or trainability of this Pomeranian. There is no guarantee against accidents.

If the new owner choose to have the Pomeranian examined by a Veterinarian of their own choice they have 48 hours of the time of purchase at the buyers own expense. If the Veterinarian examination indicates the Pomeranian is not as described in our Veterinarian's records, is diseased or has an unreported genetic defect the buyers Veterinarian must sign a written statement attesting to their findings.

The buyer must return the Pomeranian within 96 hours of purchase at the buyers expense with the written statement from the buyers Veterinarian as to the health condition. The Pomeranian will be replaced when one becomes available from Winterhaven Kennels. Replacement is the only option.

I Sandra Beisel advise the new owners to continue with the food the Puppy/Adult has been raised on and which we have provided for you and to continue Veterinarian care for vaccinations and care of puppy teeth.

This agreement is for the mutual benefit to protect you as well as us. Your signature assures you understand that you have bought a Veterinarian examined Registered Pomeranian. Ross and Sandra Beisel of Winterhaven Kennels are not responsible for any debts or charges from you or your Veterinarian once this Pomeranian leaves Winterhaven Kennels. Deposits and Payments should you decide you do not want this Pomeranian are Non Refundable.

This Contract represents the entire agreement between the parties. No other agreement or promises, verbal or implied are included unless specifically stated herein.
